How do I Participate?

- 1) Place your **One-Time Order** or sign up for a **Standing Order** (memorized order) for the 1st and/or 15th of each month.
- 2) Scrip Order Forms are available at any campus or through our website.
See contact information on the back page of this brochure.
- 3) You can expect delivery for One-Time Orders within 1-2 weeks, or sooner if available through on-hand inventory. Standing Orders will be filled and delivered based on Order & Fill Dates. *See Order & Fill Dates on the back page of this brochure.*
- 4) One-Time Orders require payment at time of order. Standing Order payments are due within 7 days of receipt of order. Your account must be current in order to receive additional orders.
- 5) Scrip can be picked up at any campus or mailed to your house.

Frequently Asked Questions

Q) When can I order?

A) Anytime! But be sure to check out our ordering schedule to make sure you get what you need when you need it.

Q) What can I order?

A) Anything that's on our Order Form, our website, or Great Lakes website (the national scrip company from which we order). New vendors are added all the time, almost daily!

Q) What is the difference between a One-Time Order and a Standing Order?

A) One-Time Orders may be placed anytime by ordering online, calling the Scrip Office, emailing Karol, or submitting a Scrip Order Form. Remember to check for on-hand Scrip!

A) Standing Orders are memorized orders that are filled the 1st and/or 15th of each month. Order online, call the Scrip Office, email Karol, or submit a Scrip Order Form to set up your Standing Order - same form as for one-time orders; just mark the appropriate box.

How Does Tuition Credit Work?

50% of the credit is shared between participating families and TCS, based on your actual Scrip purchases, while the remaining 50% is retained to cover program operating costs. And the actual return to you is determined on when your payment reaches us. Sound confusing? How about this:

If you buy two \$25 Starbucks cards each month for six months,
here's the breakdown:

Two \$25 certificates = \$50; over six month period = \$300

TCS income at 7% = \$3.50; over six month period = \$21.00

Less Scrip operating expenses (50% average) for six months,
your Scrip income contribution would be \$10.50.

Scrip expenses include: postage, supplies,

as well as paid hours to operate the program.

Also, if the total operating hours of the Scrip

program includes 70% volunteer hours, we are

not required to pay income tax on Scrip proceeds.

Divide that by either 50% (if payment received within 14 days)

or 40% (if payment received after 14 days), and your tuition

credit will be: \$5.25 (50%) or \$4.20 (40%). And that's just

purchasing \$50 worth of Scrip each month!

Tuition credit is posted to your tuition account twice a year for the six month intervals of July-December (reflected on August tuition statements), and January-June (reflected on February tuition statements).

Please note: Because you receive dollar for dollar value, Scrip purchases are not considered donations nor are tax deductible.
